The Wisconsin Food Security Consortium believes that there are four major components that frame hunger issues. These “four legs of the table” combine to create an image of food security.

1st Leg	Family Economic Security
When families struggle to make ends meet, acquiring sufficient food through conventional means can be difficult or impossible.	
2nd Leg	Access to Affordable and Healthy Food
Gardens, CSAs, farmers’ markets and nutrition education can join to address the lack of retail food outlets that sell healthy, affordable food.	
3rd Leg	Federal Nutrition Programs
Federal nutrition programs, such as FoodShare, WIC and School Lunch provide essential food resources to protect against hunger.	
4th Leg	Emergency Food Assistance
The food banks, food pantries, soup kitchens and shelters that provide an emergency food safety net for everyone in Wisconsin.
